- I understand and accept that Maltese Rescue California (MRC) has provided me with full and complete disclosure as to the “known” health and temperament of the above dog. I further understand that MRC makes no guarantee or warrantee as to the long-term health and/or temperament of this dog. I acknowledge and accept that I am fully responsible for any and all veterinary care, expenses and liability effective immediately upon date of pick-up.
- I understand fully that I am adopting a rescue dog and that rescue dogs require time and patience as they adjust to a new home, environment and family.
- I agree to allow this dog at least one week to settle; to become more comfortable and acclimated to our family; and to adjust to our schedule before exposing the dog to new situations, people, places and/or other dogs.
- I agree to provide this dog with humane care, nutritious, healthy food, clean water and regular exercise.
- I agree that this dog will wear a collar with an identification tag and be on a leash when outside a fenced enclosure.
- As per the terms of this contract I agree that this rescue dog will reside inside my home as a beloved family member and companion, and will not be left outdoors unattended or unsupervised.
- I agree to provide this dog with veterinarian care and all recommended vaccinations.
- I understand and agree that if at any time and for any reason, I am no longer able to keep this dog; I am to notify Maltese Rescue California.
- I understand and agree that the dog is not to be given away to others, sold or placed into another home without the approval of MRC. I understand that I may be required to return the dog to MRC.
- I consent to the examination of the dog by a MRC representative at any time, and acknowledge that MRC has the right to reclaim the dog if I should fail to comply with the terms of this contract, and/or if MRC should discover any misrepresentation of fact made by me within my adoption application, and/or verbal interview.
- REFUND POLICY – I hereby acknowledge and understand that the dog’s adoption “fee” is a donation to the MRC organization and that MRC is in no way obligated to return or refund this adoption fee at any time.
- I agree to pay MRC for any and all expenses, including court costs and reasonable attorney’s fees incurred enforcing the terms and provisions of this contract.
